**ENTRY LIMITS**

The Eastern Colorado Regional Championship and the Eastern Colorado Amateur Regional Championship are limited to 16 entries per stake, and will close when limit is reached. All other stakes will be limited to the number of dogs that can be run during daylight hours and will close when limits have been reached. No more than 50% of the entries in any stake may be handled by the same handler.

This trial is being run under the flexible format and the club reserves the right to rearrange the running order, add or rearrange judges should conditions warrant.

**COURSES AND BIRDS**

OP will be a single course without bird field, no birds released. No firing of blank cartridges in puppy stakes. GOLGD, GALGD, OLGD (Ret), OGD, ALGD (Ret), AGD and OD will be single course without bird field. OP will be a 15-minute stake and OD will be 20-minute stake. Retrieving for the ALGD & OLGD will be call back for retrieve.

Bobwhite quail, and/or chukars, and/or pheasants released. Horseback handling will be permitted in all stakes. Shotguns with blank shells will not be permitted.

## PRIZES

Engraved plaque to the winners of the Eastern Colorado Regional Championship and Eastern Colorado Amateur Regional Championship stakes. Prize money for the Regional Championships will be divided as follows: \$40 from each entry will go into a pool for each stake with the winning handler receiving 60% and the runner-up handler receiving 40%.

AKC rosettes to all placed dogs in each stake.

Attention all Field Trial Participants, please remember we are guests of Ohr Farms. This is private grounds and must be kept clean. Please clean-up after and fill in any holes created by your dogs and horses. Make every effort to preserve the natural environment, including vegetation, soil, water, and wildlife. Limited water will be available for horses. Please bring water for you and your dogs.

## Waiver of Liability:

An entry in this field trial constitutes a waiver of liability to the German Shorthaired Club of Colorado, its officers, members of/or owners of Ohr Farms for any accidents, damages, or injury in reference to the attendance at this field trial in conjunction with the dogs, horses, vehicles, trailers and any other personal equipment. **All participants, staff and guests will be asked to sign a waiver of liability for Ohr Farms prior to the start of the events.**

**No training will be allowed on the trial grounds from the conclusion of the RMVC Trial to the start of the Eastern Colorado Regional Championship.**

Smoking is allowed ONLY in vehicles and campers. Once birds are released, they become property of the state. No recall devices are permitted. Rules apply during the trial and any period before or after the trial while a participant and/or guest occupy the grounds.

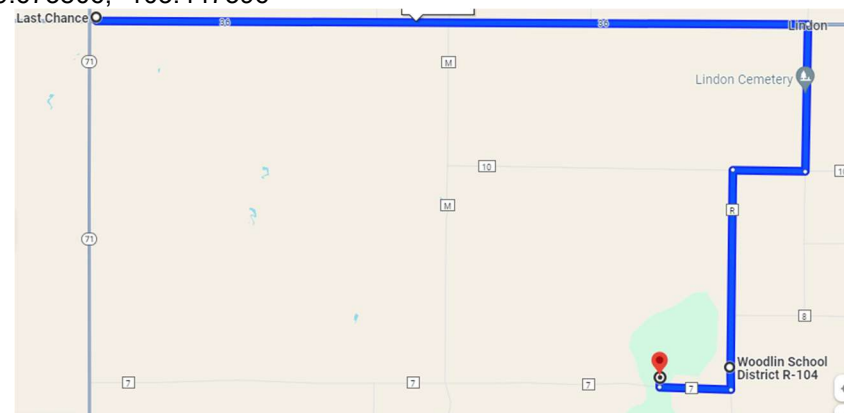
## CAMPING
