DIRECTIONS TO FIELD TRIAL GROUNDS

Int. 70 East to exit #437 or #438, Burlington. Go north on US 385 for 18.5 miles to Rd. O (Yuma cty. sign) Go east on Rd. O, which becomes Rd. RR for 6 miles. Road turns north sharply and becomes Rd. LL.5. Go north on LL.5 for 4 miles to Road 3.5 (Hale Store on SE corner), turn left, go west approx. ¾ of a mile. Camp on left side.

Camping: ONLY DRY CAMPING. No Water or Electricity at FT Site. Bring your own water for yourself and your animals.

Meals: Lunches provided for Judges.
Sunday evening Pot Luck Dinner. Burgers & Brats provided for all attending FT, please bring a dish to pass.

Animals: Move staked out horses daily. Broad cast manure. Cleanup after dogs and fill in holes.

Dog Wagon: Responsibility of handler to coordinate with Dog Wagon driver to get dogs to line. **NO Personal vehicles allowed on access roads.**

NO SMOKING ON FT GROUNDS

Smoking **ALLOWED ONLY** in vehicles and trailers.
