Exit # 419, off of I-70, Stratton, Colo. Exit go north to blinking light turn right.  
Go 14 mile on Rd. 31, (hwy. 57)  
Turn east on road KK, go ½ mile east FT grounds on north side of road.

**Camping:** ONLY DRY CAMPING. No Water or Electricity at FT Site. Bring your own water for yourself and your animals.

**Meals:** Lunches provided for Judges.  
Saturday evening Pot Luck Dinner. Burgers & Brats provided for all attending FT, please bring a dish to pass.

**Animals:** Move staked out horses daily. Broad cast manure. Cleanup after dogs and fill in holes.
