The Hunt Test Committee reserves the option to rearrange the running order, judges, start times and fields should conditions warrant.

All tests are open to all AKC Registerable Pointing Breeds that are at least 6 months of age. Bitches in season may compete in the last test run of the day. Licensed Hunt Tests are held under the rules and regulations of the **American Kennel Club**.

COURSES AND BIRDS

Senior and Master Hunt Tests will run 30 minutes. Junior Hunt Test will run 15 minutes. Tests will run on a single course with bird field.

Quail and/or Chukar and/or Pheasants will be released in all stakes. Judges and officials only are allowed to use horses. Shotguns with NO ammunition will be permitted to be carried by handlers of Master dogs only. **Participants must wear blaze orange on all courses.** Galleries are permitted only at the discretion of the hunt test committee and judges when safety permits, are under the control of the marshal, and not permitted in any bird field.

Entry Fees include a \$3.00 Processing Fee. Entries may be cancelled or changed online prior to close of entry, with refunds (less a Processing Fee of \$3 per entry and \$1 per camping item) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and camping items may be cancelled online after close of entry, but no refunds will be given. Once an entrant is drawn and braced, it may run as entered, move up to the next test level, or scratch without refund. Refunds (less the \$3 Processing Fee) will be granted only for bitches in heat, injured, or sick dogs (may require vet certification); or as deemed an emergency by the event committee. Entrants who complete a title during #2018661103 may request advancement to the next level for event #2018661104 to the event secretary within 30 minutes of the test start.

Go North into town on Colorado Ave. for ½ mile

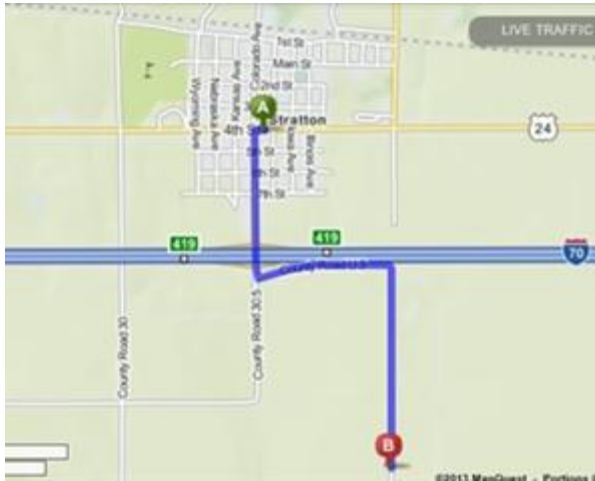
Turn Left (West) on 4th Street (Hwy 24) for ½ mile.
