The Hunt Test Committee reserves the option to rearrange the running order, judges, start times and fields should conditions warrant.

All tests are open to all AKC Registerable Pointing Breeds that are at least 6 months of age. Bitches in season can only run at the END of the DAY if the stake's JUDGES ARE AVAILABLE and if APPROVED BY THE HUNT TEST COMMITTEE. We will do our best to accommodate, but cannot guarantee a bitch in season can run.

Licensed Hunt Tests are held under the rules and regulations of the **American Kennel Club**.

Once an entrant is drawn and braced, it may run as entered, move up to the next test level, or scratch without refund. Refunds (less the Processing Fee) will be granted only for bitches in heat, injured, or sick dogs (may require vet certification); or as deemed an emergency by the event committee. Entrants who complete a title during #2025661103 may request advancement to the next level for event #2025661104 to the event secretary within 30 minutes of the test start.

Fees for entries and any extras (meals, parking, etc.) include a Processing Fee. Entries and extras may be cancelled or changed online prior to the closing date, with refunds (less the Processing Fee per entry) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and extras may be cancelled online after the closing date, but no refunds will be given.

ADVANCED TITLES

AKC has Advanced titles (JHA, SHA, and MHA). A Pointing Breed Hunting Test Advanced title is awarded when a dog passes five additional times with an average qualifying score of 8.0 or higher after earning its initial title in a test level. PRIZES

Standard AKC Rosettes will be awarded to all dogs receiving a qualifying score.

WAIVER OF LIABILITY

An entry in this hunting test constitutes a waiver of liability to The Rocky Mountain Vizsla Club, its officers, members of/or owners of Ohr's Ranch for any accidents, damage or injury in reference to the attendance at this hunting test in conjunction with the dogs, horses, vehicles, trailers and any other personal equipment.

COURSES AND BIRDS

Senior and Master Hunt Tests will run 30 minutes. Junior Hunt Test will run 15 minutes. Tests will run on a single course with bird field.

Quail and/or Chukar and/or Pheasants will be released in all stakes. Judges and officials only are allowed to use horses. Shotguns with NO ammunition will be permitted to be carried by handlers of Master dogs only. **Participants must wear blaze orange on all courses.** Galleries are permitted only at the discretion of the hunt test committee and judges when safety permits, are under the control of the marshal, and not permitted in any bird field.

TRACKING COLLARS

Tracking collars can be worn but must adhere to AKC rules: https://www.akc.org/sports/pointing-breeds/tracking-devices/

If an Event Committee determines a violation of these Regulations may have occurred, the accused (which includes anyone involved in the misuse of the tracking device including the act of communicating improperly obtained information) shall be charged with misconduct. An Event Committee hearing must be held. If the Event Committee determines through the hearing process that a violation did occur, the accused shall be immediately suspended from all forms of participation in AKC Pointing Breed field events. The dog shall be disqualified from the stake.

MEALS AND CAMPING

Please note: There will be a field trial on adjacent grounds on Saturday and Sunday. The groups will be sharing the parking area. Therefore, if you have an RV, please make a reservation with your entry as we will be assigning spaces

Camping is permitted on the grounds for \$12/night but there are no hookups. You may reserve and prepay on perfdog.com or enclose a check payable to PerfDog if you mail your entry.

Please arrange for your own food and water. No food or beverages will be available onsite for lunch, exception is for judges and volunteers.

RMVC will sponsor dinner on Saturday night. Any payment will be collected on site.
