All stakes open to all AKC registrable pointing breeds. Bitches in heat are eligible for entry in stakes that conclude at the end of each day. This field trial is held under the rules and procedures of the American Kennel Club.

Entries close on Monday, September 22nd at 5:00 PM, or when the limit of entered dogs that can be run during daylight hours is reached. Entries accompanying the last entry may be accepted. Drawing will be held on September 22nd at 6:00 PM at 1425 Excelsior Creek Avenue, Montrose, CO 81401.

Please note: Ohr's Ranch will be charging \$10 per night, per rig for overnight camping. Please pay at the event with a check.

- This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order of the stakes and add/rearrange judges should conditions warrant.
- The FT Secretary must be notified a bitch has come into season at least one-half hour prior to the beginning of the stake in which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.
- Shotguns with blank shells will not be permitted.
- AKC approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.
- Fees for entries and any extras (meals, parking, etc.) include a Processing Fee. Entries and extras may be cancelled or changed online prior to the closing date, with refunds (less the Processing Fee per entry) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and extras may be cancelled online after the closing date, but no refunds will be given.

STAKE AND EVENT LIMITS

Entries are limited to the number of dogs that can be run during daylight hours.

COURSES AND BIRDS

Courses without bird fields. No birds and no firing of blank cartridges in puppy stakes. Derby Stakes 20 minutes. Puppy Stakes 15 minutes. Gun Dog Stakes 30 minutes. Call backs for OGD RET and ALGD RET - **everyone must wear blaze orange**. Quail, Chukar and/or Pheasant will be released in all stakes except Amateur Walking Puppy and Open Puppy.

PRIZES

Rosettes will be awarded to all placing dogs in each stake.
