COURSES AND BIRDS

Open Puppy single course without bird field. Open Derby, Open All-Age, Open Gun Dog, Amateur Gun Dog, Open Limited Gun Dog, Amateur All Age Single course without bird field. Native quail, and/or pheasants on all courses. Birds will be released in all stakes except open puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes. There are wild turkeys in this area.

PRIZES

AKC standard rosettes to all placed dogs. Trophies to 1st place dogs in all stakes. Open Limited gun Dog is a money stake.
50% of entry fee retained by the club, remaining 50% will be paid as follows: 50% to 1st, 30% to 2nd, AND 20% to 3rd PLACE

Additional DOW Field Trial Rules

1. All motor vehicles must use only established public roads. The only exception is the road to the corral. Designated dog wagon is the only vehicle allowed off- road.
2. Overnight camping and staking horses overnight is limited. Please let the Field Trial Secretary know if you wish to do either.
3. Only Certified Weed Free hay may be fed on the Field Trial Grounds. Please let the Field Trial Secretary know if you wish to purchase Weed Free Alfalfa Hay. It will be available for purchase at the grounds.
4. Participants are encouraged to stable horses at the Fair Grounds in Burlington. The fee is \$5.00 per night. Also, please make sure you clean the stables you use each night.
5. Please fill in all dog holes, pick up dog manure and scatter all horse manure.
6. Even though garbage cans exist, please pack out all trash.
7. Please note the attached map for overnight camping, parking and taking out horses. If these areas are full, please ask a Field trial Committee member for the alternate site.

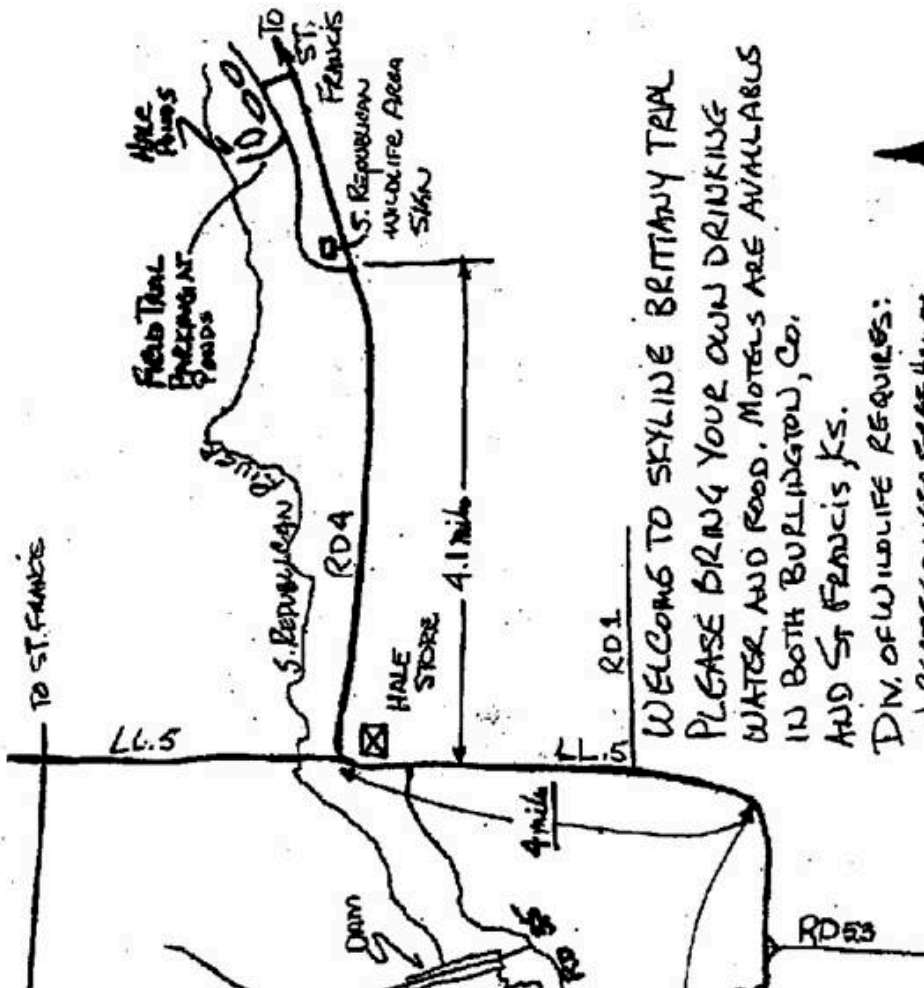

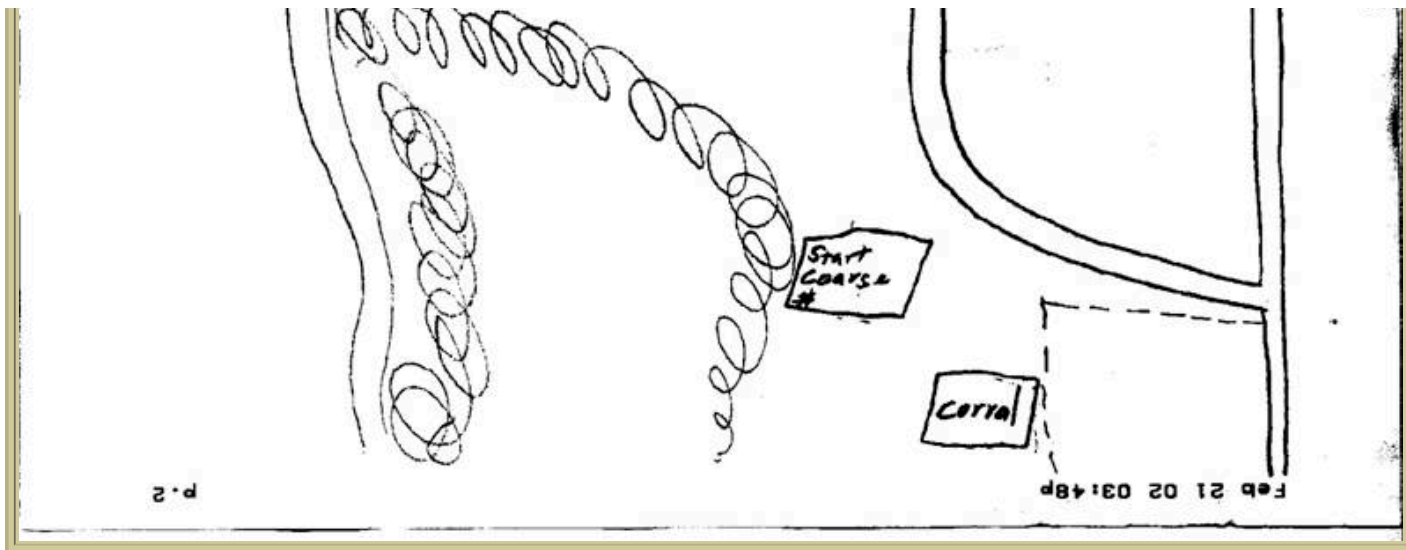
