COURSES AND BIRDS

Open Ltd. Gun Dog, Open Gun Dog and Amateur Ltd. Gun Dog are retrieving stakes and will be with bird field. Amateur Puppy and Open Puppy will be single course without bird field. A blank cartridge will not be fired in the puppy stake. Amateur Gun Dog, Open Derby and Amateur Derby will be single course with birds released. Bobwhite quail will be released in all stakes except open puppy and amateur puppy. Shotguns with blank shells will be permitted. Orange vests will be required on coarse.(BRING YOUR OWN ORANGE VEST). Retrieving stakes, 22 minute back course/8 minutes in bird field. No Horse back handling will be permitted. A horse back gallery will be permitted, except in the bird field. Only handlers /judges with gunners allowed in bird field.
