COURSES AND BIRDS

Open Puppy & Amateur Walking Puppy single course without bird field, no birds released. All other stakes on single course without bird field. Bobwhite quail, and/or chukars, and/or pheasants released in all stakes except open puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes except Amateur Walking Puppy and Amateur Walking Derby. Shotguns with blank shells will be permitted.

PRIZES

All placed dogs to receive AKC Rosettes. Open Limited Gun Dog is a money stake. 50% of the entry fee will be divided 50% to First, 30% to Second and 20% to Third. Mile High Weimaraner Club retains money for any placements withheld.
