Bobwhite quail will be released in all stakes except Open Puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes. Shotguns with blank shells will not be permitted.

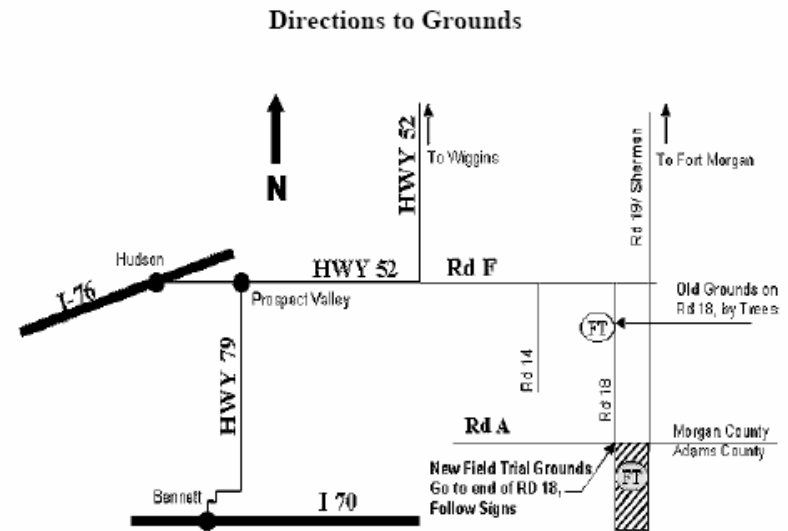
