Courses and Birds

Open Puppy single course without bird field, no birds released. All other stakes to be single course without bird field.

Bob-white quail and/or chukars and/or pheasants released in all stakes except Open Puppy. A blank cartridge will not be fired in the Open Puppy stake. Horseback handling is permitted in all stakes. This trial will be recognized by the AFTCA.

All blank guns must have a solid barrel or be plugged
No live ammunition allowed on the grounds.

Trophies to 1st place dogs in all stakes

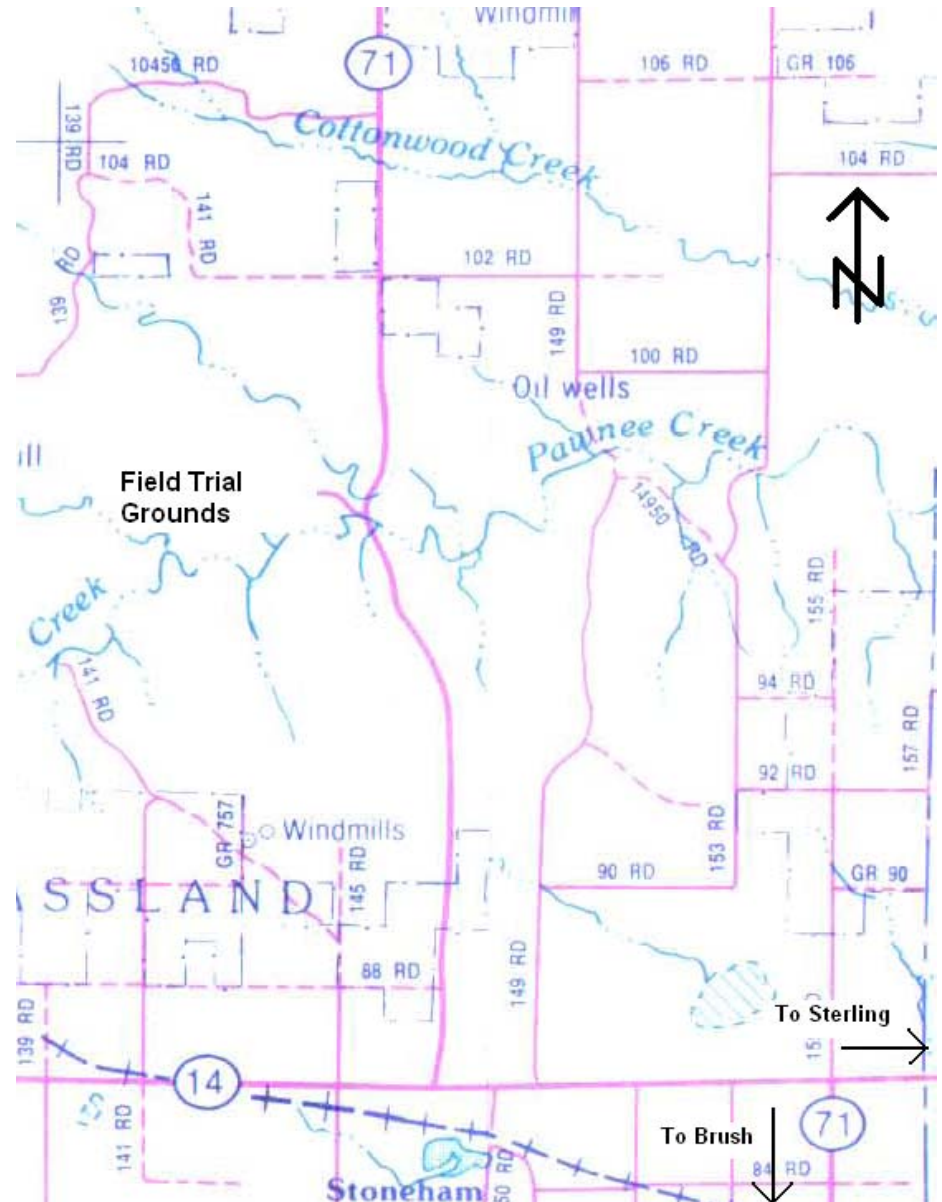
