 Judges & Officials will be allowed to use horses

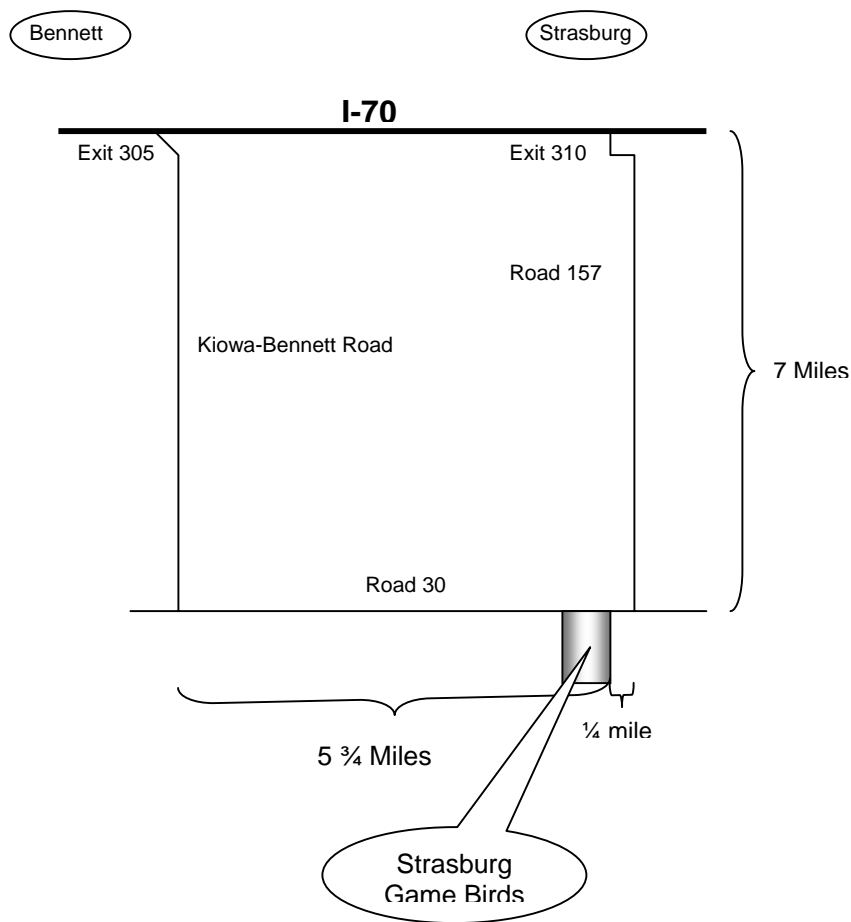
