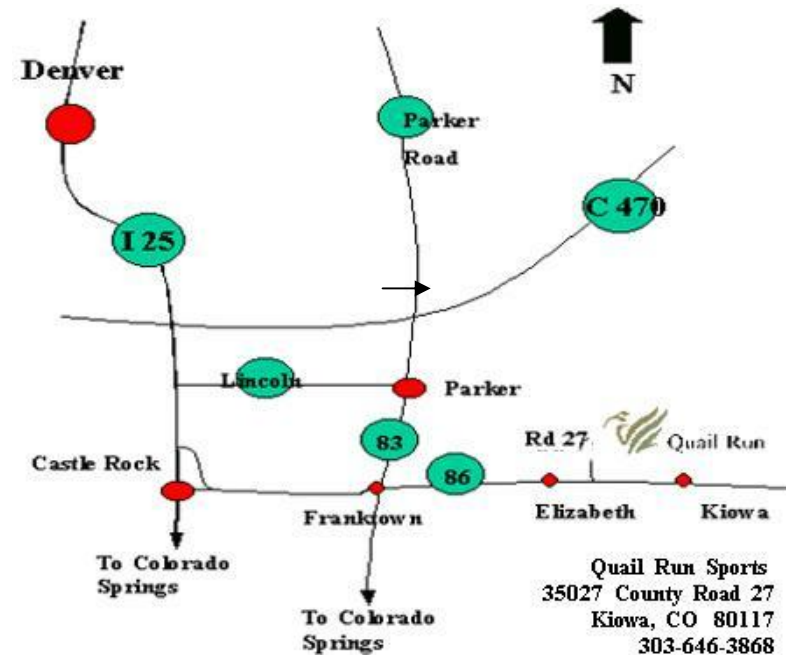
## LOCATION
