Coming from South: Take Hwy 86 to Agate sign; turn left onto CR 153; head north for 8 miles to WTR sign and balloons then travel west 1 mile.

The entry to the trial grounds will be marked with a WTR (Windtuck Ranch) sign and orange streamers. We have drinking water available for dogs and horses.
