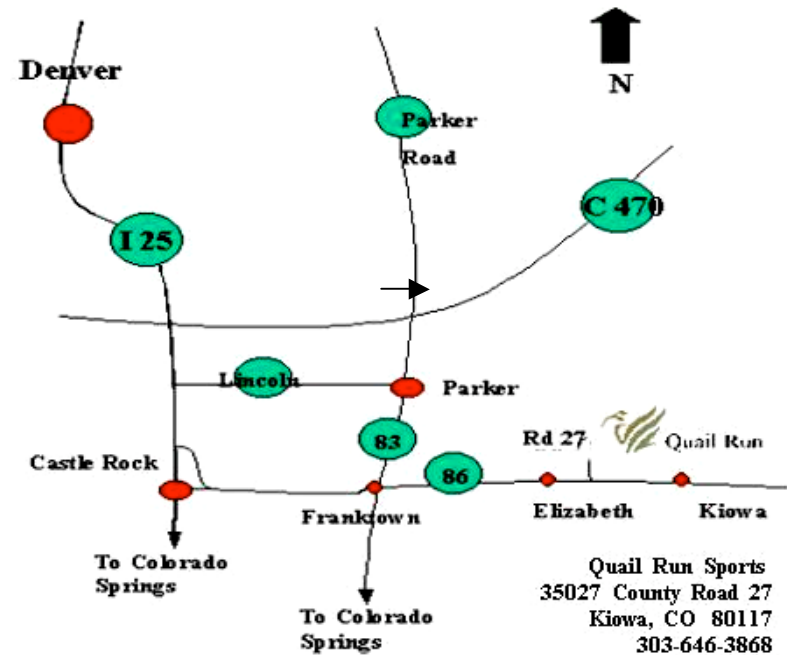
LOCATION
