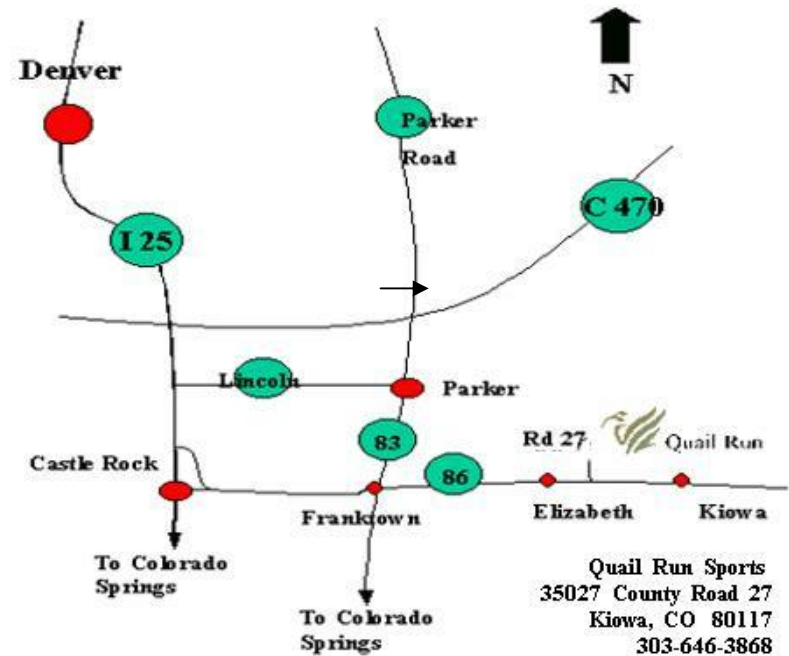
LOCATION
