All blank guns must have a solid barrel or be plugged
 No live ammunition allowed on the grounds.

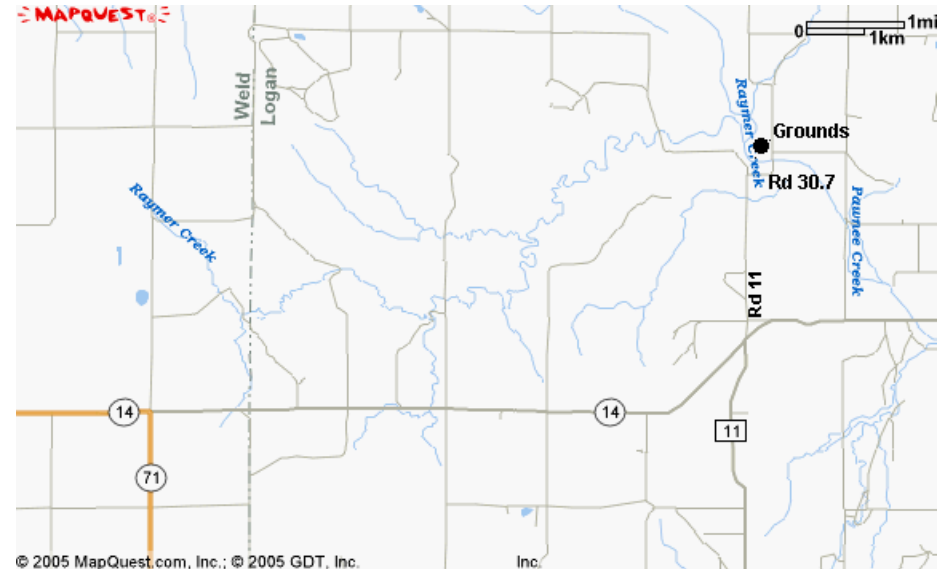

From Brush, CO: Take State Hwy 71 north to State Highway 14. Go east (right) on SH 14 to County Road 11. Go north (left) on CR11 about 2 miles to County Road 30.7. Go east (right) on CR 30.7 about ¼-mile until it turns north (left) and becomes County Road 11.2. Continue on CR 11.2 another ¼-mile, the grounds will be on your left. **An alternate site may be used further to the north on CR 11.2, follow the signs or flagging tape.**
