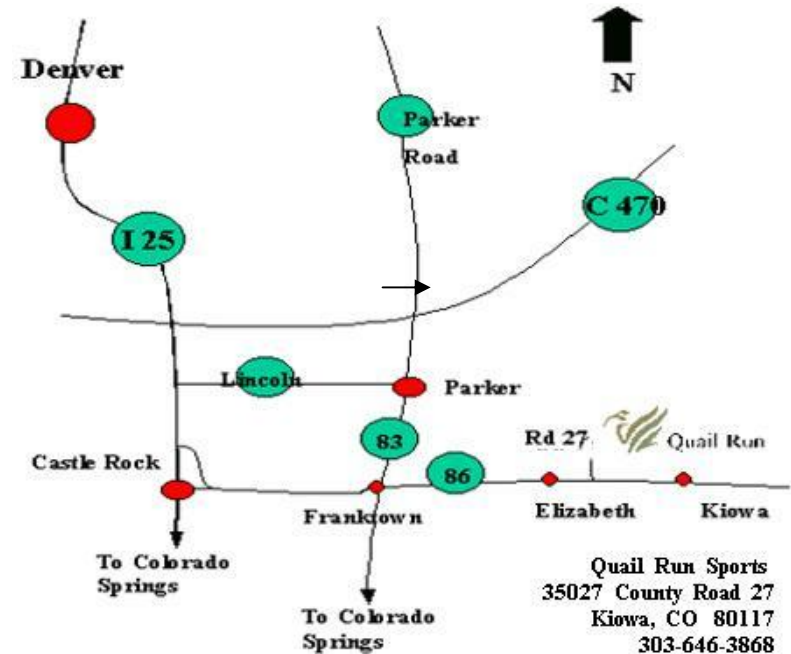
## LOCATION
