All stakes are open to all AKC registered Pointing Breeds 6 months of age or over. Bitches in season are not eligible for entry in any stake.

## COURSES AND BIRDS

Single course without birdfield for all stakes. Open Puppy 15 minutes, birds released. A blank cartridge will not be fired in the puppy stake. Open Derby 20 minutes. Open Gun Dog 30 minutes. Bobwhite quail, chukar and/or pheasant will be released in all stakes. All stakes are walking, horseback handling will not be permitted in any stake. Shotguns with blank shells will not be permitted.
