WCA Ratings tests shall be open to all Weimaraners 6 months of age or older. All members and co-owners must be members of WCA. Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. **PRIOR to being entered in a ratings test**, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All Weimaraners with AKC ILP numbers are allowed to participate without applying to the National Office. Bitches in season will be permitted to run last in these tests.
