Directions:

From Highway 36 and 71 (Last Chance, CO): Go east toward Lindon, CO. Go right (south) on Road S for 4 miles. Go right (west) on Road 8 for 1 mile. Go left (south) on Road R for 1 mile. Go right (west) on Road 7 for 1 mile. Go right (north) on Road Q for ½ mile. Road Q is poorly marked and looks like a farm road. Watch for signs.

Smoking is allowed **ONLY** in vehicles and campers. No training is permitted on the grounds before or after the trial. Once birds are released, they become the property of the state. No recall devices are permitted.

Rules apply during the trial and any period before or after the trial while a participant and/or guest occupies the grounds.

Due to the large number of entries, the Open Limited Gun Dog will start on Friday at 7:00 AM on Course #2. The Open Limited Gun Dog will be an out and back course. Handlers make sure you have your dogs properly identified for the dog wagon driver. The Open Derby will start on Saturday following the Open Puppy on Course #2.

Please note the judging changes on the bracing sheets. The castoff times on the bracing sheets are only approximations. Please have your dogs at the line ready for castoff.

There is limited parking area at the trial grounds. Please use only the room you need and keep the roadway open for the dog wagon and other traffic. Dave and Liz Klein will be providing breakfast, lunch and dinner on Friday and Saturday and breakfast and lunch on Sunday for a reasonable fee. We appreciate everyone supporting them.

The water provided is limited to horses. Bring your own dog water.
