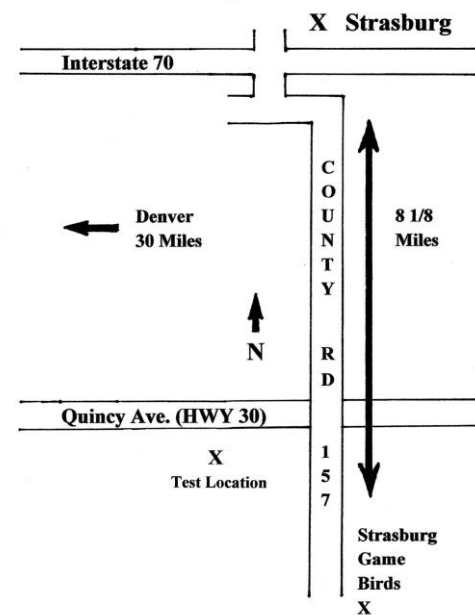

Drive south approximately 6 1/2 miles to Quincy Ave. (HWY 30). Turn right (west) onto Quincy and drive approximately 1/2 mile. Turn left (south) onto dirt trail and drive to the parking lot.
