## COURSES AND BIRDS

Senior and Master Hunt Tests will run 30 minutes. Junior Hunt Test will run 15 minutes. Tests will run on a single course with bird field. Quail, Chucker and/or Pheasant will be released in all stakes. Judges and officials only are allowed to use horses. Shotguns with blank shells will not be permitted. Only starter pistols with blank cartridges may be fired by handlers. Participants must wear blaze orange on the senior and master courses. Galleries are permitted only at the discretion of the hunt test committee and judges when safety permits, are under the control of the marshal, and not permitted in any bird field.
