- Single course without bird field for all stakes.
- Horseback handling will be permitted in all stakes.
- Puppy Stakes 15 minutes, birds will NOT be released; a blank cartridge will not be fired in the puppy stakes.
- Derby Stakes 20 minutes.
- Gun Dog Stakes 30 minutes. ALGD will have callbacks for retrieving.
- Quail, Chucker and/or Pheasant will be released in all stakes.

PRIZES

- Rosettes will be rewarded to all placing dogs in each stake.
