



Courses and Birds

Retrieving Championship: First series: 30 minutes single course without a bird field. Retrieving on course. For dogs in contention, Second Series: A 45 minute single course without a bird field. Retrieving on course. Mandatory retrieving required in both series. Chukars released in both series.

<u>Non Retrieving</u>: One-hour series, single course without a bird field. Chukars will be released.

Note: Any dog considered in contention, which has not had the opportunity for a retrieve, will be given a call back for retrieve the day of their run at the discretion of the judges.

All stakes will be judged in accordance with AKC Pointing Breed Gun Dog standards.

Horseback handling permitted in both stakes; collaring permitted in both stakes. All horses will be kept at a FLAT WALK.

Blaze Orange MUST BE WORN in RETRIEVING CHAMPIONSHIP

Bitches in season permitted in both stakes.


All shooting in the Retrieving Championship will be on course by official gunners.

Scratch Policy

Per AKC Field Trials Rules and Standard Procedure for Pointing Breeds - Entries will be refunded in full only to dogs that have injury or illness that prevent running in the registered stake or that are deceased prior to running in the registered stake. The GSPCI and Gun Dog Assoc. clubs may require an appropriate veterinary certificate.

Directions to Field Trial:

The field trial grounds are approximately 17 miles South of Marsing, Idaho on Hwy 95. The trial grounds are on the South side of Hwy 95, at the Mile Marker 9 post. Look for field trial signs.
