All stakes will be single course without birdfield. Chukar will be released in all stakes, except open puppy. No birds released in open puppy. OGD and AGD are retrieving stakes. OP and OD are non retrieving stakes. Dogs in contention for retrieving stakes will be called back for a retrieve. A blank cartridge will be fired on all course birds. A blank cartridge will be fired in open puppy and open derby. Horseback handling will not be permitted in any stake. Shotgun blanks not permitted.
