**Courses and Birds**

There are two courses: Course A is for Puppy and Derby events.  
 Course B is for all other stakes.

Open Puppy and Open Derby are non-retrieving stakes. Birds will be blanked on course.

Open Limited Gun Dog, Open Gun Dog, Open All-Age, and Amateur Gun Dog are retrieving stakes. Birds will be blanked on course, with a Call Back for the retrieve.

Chukar, quail, or pigeons planted in all stakes except Puppy.
