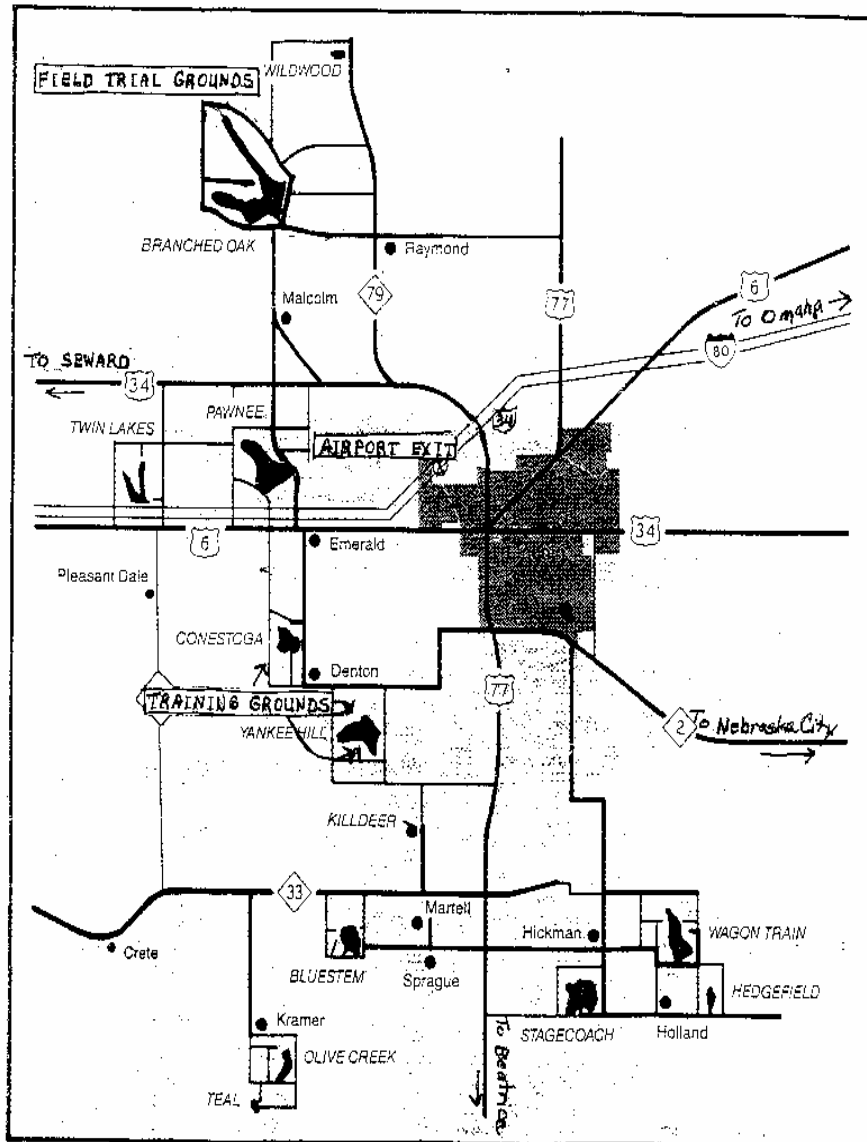

Directions to the Trial Grounds: From Interstate 80, take Hwy W34, 4.5 miles Northwest of Lincoln. Turn right (north) on Hwy 79 and go 5 miles to West Raymond Road. Turn left (west) and go 3 miles. Take a hard right and follow the blacktop around the lake for 5 miles. The field trial grounds are located at the Northwest corner of the lake. The entrance is on your left, marked with a sign.

Camping: Overnight camping is allowed on the grounds. There is a \$3.00 charge for electrical hook-ups – payable to the Field Trial Chairman. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds.

Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.

Training: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.

Horses: Horses will not be available. For those of you bringing your own horses, pens are available on a first come, first served basis. There are also designated stakeout areas for horses.

Entries: Telephone entries are NOT accepted. All entries must be completed in full and fees MUST be paid to the Field Trial Secretary before the entry closing time.
