### General Information:

**Directions:** The Field Trial grounds are located north of Magdalena NM. Take NM 60 to the west end of Magdalena. Turn on NM 169 North (sign says to Alamo Reservation). After you pass thru the Alamo reservation you will get to straight newly paved road. Proceed approx. 2 miles and look for the Nance ranch house, yellow barns & green kennels to the left, and WCA signs into the trial grounds. Distance from Magdalena turnoff to trial ground is about 38 miles.

If coming from north via Albuquerque there is an alternate route, which is shorter, but has 30 miles of dirt road. Call Linda Stake for directions, 294 7948.

**Camping: The Field Ranch is the privately owned ranch of Jim Nance.** Camping is allowed in designated areas of the grounds. Please carry off all your trash. Fill in any holes and spread horse manure/left over hay. Toilet facilities will be provided. Water for dogs and horses will be available.

Mr. Nance is the Master of Foxhound Hunting/ District Director for the southwest USA. No coyote hunting is allowed on his ranch.
