**PRIZES**

TROPHIES AND/OR PRIZES AND A.K.C. ROSETTES TO ALL PLACED DOGS  
WCA ROTATING TROPHIES TO FIRST PLACE DOG IN OPEN ALL-AGE, AMATEUR GUN DOG AND OPEN DERBY.
