# WAIVER/RELEASE OF LIABILITY

In consideration of and as a condition of \_\_\_\_\_ being allowed to participate in field trials on certain land in Elbert County, Colorado located at 12400 County Road 102, Elbert, CO, 80106-9207 owned Spero M. Manson (collectively the "Manson Ranch"), the undersigned acknowledges, represents, and agrees that:

1. Participating in field trials and related activities, including riding horses, are inherently dangerous activities that can result in serious injuries or death caused by myself or other people who are present or participating in such activities. I hereby expressly agree to assume all risks, both known and unknown, and I understand that I may be seriously injured or killed through my acts or the accidental or negligent acts of others.
2. Participating in field trials also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals, insects or hazardous water crossings. Spero M. Manson and the "Manson Ranch" have not made any representations or warranties, express or implied, that the conditions of the property are suitable for field trials or that the property is free from defects, including any roads, buildings, structures, gates, creek crossings, or any other possible dangerous or hazardous condition. Further, I acknowledge that I will be solely responsible for safety and condition of any and all horses and equipment utilized by me.
3. I acknowledge that in allowing me to participate in a field trial activity on the "Manson Ranch", Spero M. Manson and/or his representatives owe me no duty to supervise or control the activities or the actions of the persons present or participating in such activities.
4. I, for myself, my spouse, my children, and on behalf of my/our heirs, successors and assigns, hereby release and agree to protect, indemnify, and hold harmless Spero M. Manson, the "Manson Ranch" owner, his respective heirs, agents, members and assigns, or any of the entities or corporations of which they are a part from any and all injuries, disabilities, deaths, losses, claims, demands, causes of action and damages, including attorney's fees, resulting from an accident, incident or occurrence arising out of, incidental to, or in any way resulting from my participation in a field trial or related activity on the "Manson Ranch", whether or not caused by the Spero M. Manson and/or his representative's negligence or gross negligence.
