Bitches in season may compete in the Amateur Gun Dog only. AKC approved tracking collars may be used in all stakes per AKC regulations.

Total entries for other stakes limited to the number that can be run during daylight hours (approx. 65 dogs). Entries will close when this limit is reached if this occurs prior to the specified closing time. Entries accompanying the last entry may be accepted. No more than 50% of the entries in any one stake may be handled by the same handler.

All blank guns must have a solid barrel or be plugged

Grounds: 39°14'12.18"N, 104°26'11.71"W

From Franktown, CO: Take State Hwy 86 east to Maul Road (20 miles).

From Kiowa, CO: Take State Hwy 86 east to Maul Road (4 miles).

Go south (right) on Maul Road 6.5 miles until it ends at County Road 102.

From Elbert, CO: Go East on CR 98 (1 mile), Go north (left) on CR 33/CR 102 (5 miles to Maul Road.

The grounds will be through the gate on the south side of the intersection.
