COURSES AND BIRDS

Open Puppy single course without bird field, no birds released. Open Gun Dog, Open Limited Gun Dog (RET), Amateur Limited Gun Dog (RET), Amateur Gun Dog, & Open Derby single course without bird field.

Open Derby is 20 minute stake.

Amateur Limited Gun Dog (RET) & Open Limited Gun Dog (RET) are a Call Back to Retrieve. Bring your BLAZE ORANGE.

Bobwhite quail, and/or chukars, and/or pheasants released in all stakes except open puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes. Shotguns with blank shells will not be permitted.
