ENTRY LIMITS

The Eastern Colorado Regional Championship is limited to 32 entries and will close when limit is reached. The limit of entered dogs for all other stakes is limited to the number that can be run during daylight hours and will close when limits have been reached. If it occurs prior to specified closing time. No more than 50% of the entries in this stake may be handled by the same handler.

This trial is being run under the flexible format and the club reserves the right to rearrange the running order of the stakes and add/rearrange judges if the size of the trial cannot be accommodated by the plan in this premium.

COURSES AND BIRDS

Open Puppy single course without bird field, no birds released. The Regional Grand Open Limited Gun Dog, Open Gun Dog, Amateur Gun Dog, Open Limited Gun Dog (RET), Amateur Limited Gun Dog (RET) & Open Derby single course without bird field. Retrieving for the Open Limited Gun Dog (RET) will be call back at the end of the stake. **Amateur Limited Gun Dog (RET) will be retrieving on course. Everyone on course must wear BLAZE ORANGE.**

Bobwhite quail, and/or chukars, and/or pheasants released in all stakes, except Open Puppy. Horseback handling will be permitted. Shotguns with blank shells will not be permitted.

PRIZES

Engraved plaque to winner of the Eastern Colorado Regional Championship stake. Prize money for the Eastern Regional will be divided as follows: \$40 from each entry will go into a pool with the winning handler receiving 60% and the runner-up handler receiving 40%.

AKC rosettes to all placed dogs in each stake.

Attention all Field Trial Participants, please remember we are guests of the Ohr Ranch. This is private grounds and must be kept clean. Please clean-up after your dogs and fill any holes created by dogs or horses. Make every effort to preserve the natural environment, including vegetation, soil, water, and wildlife.

All participants will be asked to sign a waiver of liability prior to the start of the events.

No training will be allowed on the field trial grounds from the conclusion of the RMVC Trial to the commencement of the Eastern Colorado Regional Championship.

Smoking is allowed ONLY in vehicles and campers. Once birds are released, they become property of the state. No recall devices are permitted. Rules apply during the trial and any period before or after the trial while a participant and/or guest occupy the grounds.

Please bring your own drinking water and dog water. LIMITED water will be available for horses.

MEALS

The club will offer a meal of Sloppy-Joes on Friday night. Please bring a side dish or desert to share.

Saturday night, the GSPCC will be offering a complete brisket dinner. Please bring your own drinks.

For other meals, please bring your own food and drinking water.

CAMPING

Ohr's Ranch will be charging \$10 per night per rig for overnight camping beginning Wednesday, October 4, 2023. There are no hookups available. There will be hydrants on site to fill tubs with water. Please pay at the event with a check payable to GSPCC.

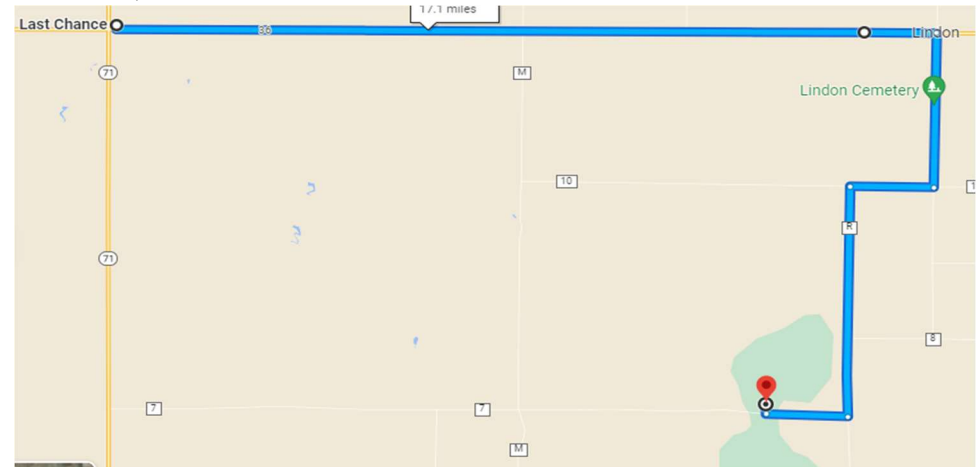
