ENTRY LIMITS

The Eastern Colorado Regional Championship is limited to 16 entries and will close when limit is reached. All other stakes will be limited to the number of dogs that can be run during daylight hours and will close when limits have been reached. OGD may conclude on Sunday if entries warrant. No more than 50% of the entries in any stake may be handled by the same handler.

This trial is being run under the flexible format, and the club reserves the right to rearrange the running order, add or rearrange judges should conditions warrant.

COURSES AND BIRDS

All stakes are non-retrieving. OP & AWP will be a single course without bird field, no birds released. No firing of blank cartridges in puppy stakes. OD, AGD, OGD, AWGD, AWD will be a single course without bird field. OP & AWP will be a 15-minute stake and OD & AWD will be 20-minute stake.

Bobwhite quail, and/or chukars, and/or pheasants released. Horseback handling will be permitted only in OP, OD, AGD, OGD & GOLGD. Walking handlers are welcome in all stakes. Shotguns with blank shells will not be permitted.

PRIZES

.AKC rosettes to all placed dogs in each stake.

Prize money for the Regional Championships will be divided as follows: \$40 from each entry will go into a pool for each stake with the winning handler receiving 60% and the runner-up handler receiving 40%.

Meals:

The GSPCC is planning a lasagna dinner on Saturday evening. Please bring a dish to share and your own drinks.

The GSPCC will offer an exhibitor lunch on Sunday. Please bring a dish to share and your own drinks.

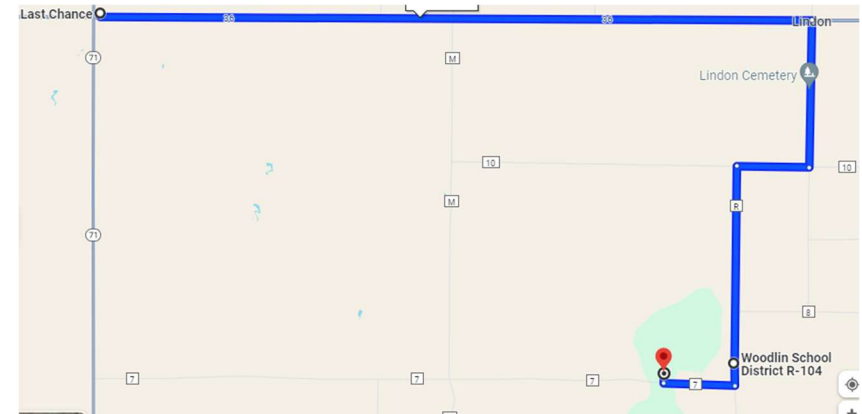
