DIRECTIONS TO FIELD TRIAL GROUNDS

From Hugo, Colorado, go south on 3rd Ave. (hwy. 109) for 11 miles
To Road 2J. Turn east (left) on 2J (this road also goes to Kinney Lake)
Continue for 1 ½ miles entrance to FT grounds on right side.

Camping: ONLY DRY CAMPING. No Water or Electricity at FT Site. Bring your own water for yourself and your animals.

Meals: Lunches provided for Judges.
Saturday evening Dinner will be provided for all attending FT, please bring a dish to pass.

Animals: Move staked out horses daily. Broad cast manure. Cleanup after dogs and fill in holes.

Dog Wagon: Responsibility of handler to coordinate with Dog Wagon driver to get dogs to line. **NO Personal vehicles allowed on access roads.**

NO SMOKING ON FT GROUNDS
