This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant. This Field Trial is held under the rules and procedures of the American Kennel Club.

The Amateur Derby is open to *Vizslas only*. All other stakes are open to all AKC registerable Pointing Breeds.

Entry Fees include a Processing Fee. Entries may be cancelled or changed online prior to close of entry, with refunds (less the Processing Fee per entry) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries may be cancelled online after close of entry, but no refunds will be given.

If you're not entering online at PerfDog please allow extra time for your mailed entries. The postal service is experiencing longer than normal delays.

Bitches in season are eligible for entry in AGD, OGD, AD and OD. The FT Secretary must be notified the bitch has come into season at least one-half hour prior to the beginning of the stake in which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.

STAKE LIMITS

All stakes are open to all AKC registrable pointing breeds (except for posted "Vizslas only"). No more than 50% of the entries in any one stake may be handled by the same handler. Entries are limited to the number of dogs that can be run during daylight hours.

COURSES AND BIRDS

- Course without bird field for all stakes.
- All stakes are walking, horseback handling will not be permitted in any stake.
- Puppy Stakes 15 minutes. Birds *will not* be released.
- Derby Stakes 20 minutes.
- Gun Dog Stakes 30 minutes.
- AGD stake will have callbacks for retrieving.
- Quail, Chukar and/or Pheasant will be released in all stakes, except puppy.
- Shotguns with blank shells will not be permitted.
- AKC Approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at:

No meals will be served by the RMVC. RV camping/horse trailer parking is available, but there are no hookups.

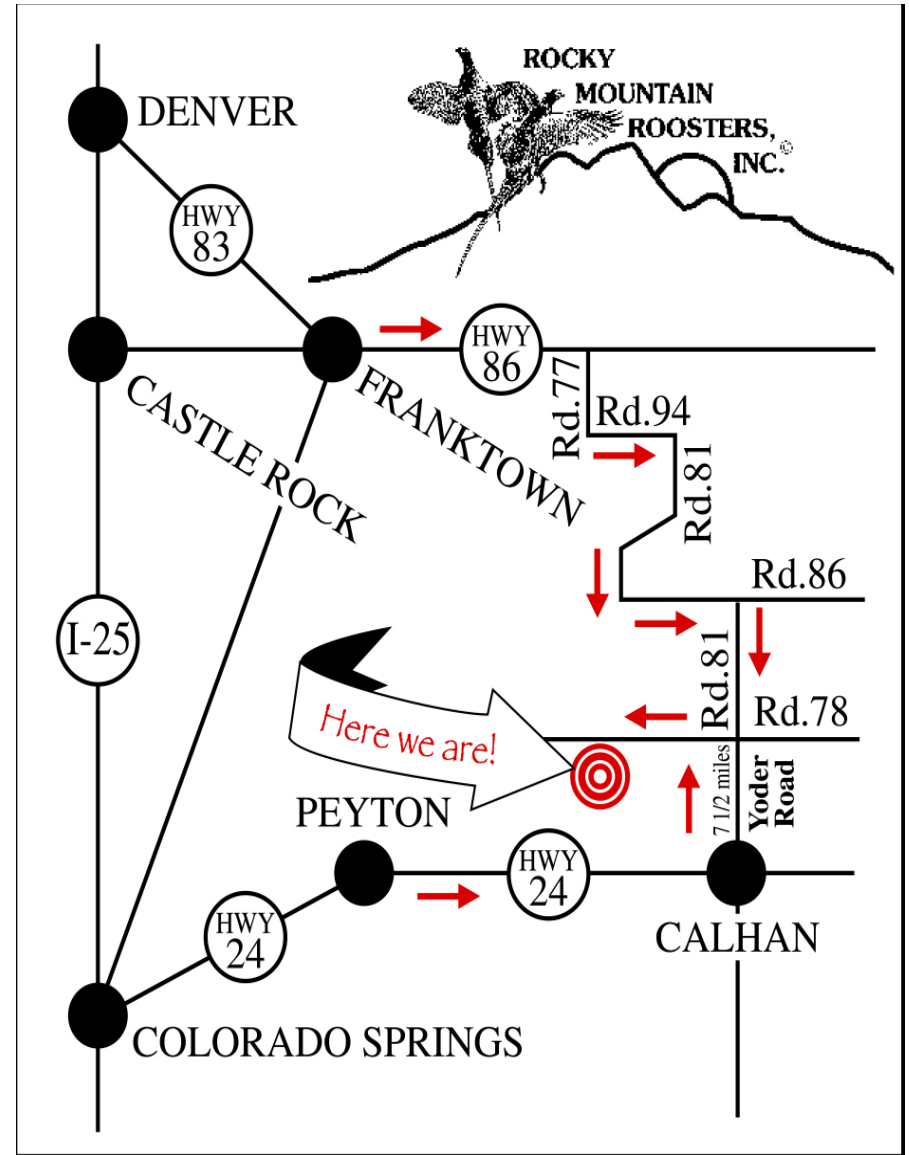
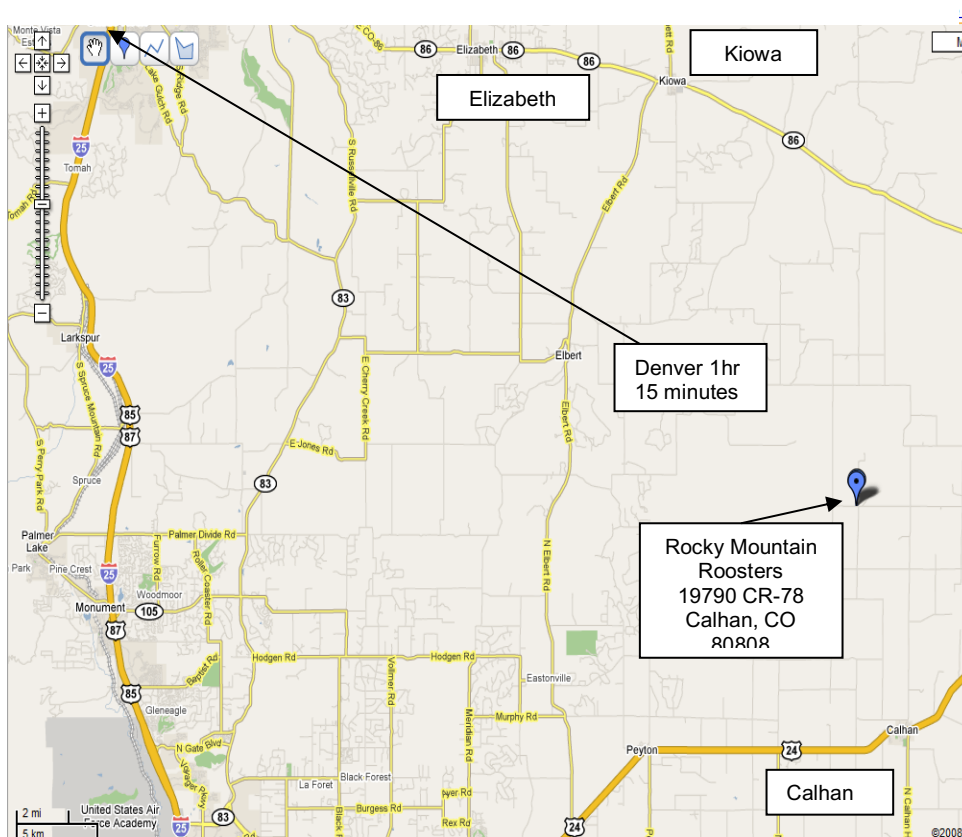
DIRECTIONS TO ROCKY MOUNTAIN ROOSTERS

FROM DENVER:

SOUTH ON I-25 TO THE FOUNDERS PARKWAY EXIT JUST NORTH OF CASTLE ROCK. (Factory outlet store here) EAST ON THE PARKWAY TO THE INTERSECTION OF HWY 86. CONTINUE EAST ON HWY 86 PAST THE TOWN OF KIOWA 9 1/2 MILES AND YOU'LL SEE A SIGN THAT POINTS TO CALHAN, THIS IS ROAD 77. (dirt roads from here on!) DRIVE SOUTH ON ROAD 77 TO THE "T" INTERSECTION (6.2 mi) , TURN LEFT ON ROAD 94 AND FOLLOW IT AROUND(1 mi) AND IT TURNS INTO ROAD 81. CONTINUE SOUTH ON ROAD 81 TO ROAD 78 (4.2 mi), TURN RIGHT AND WE ARE AT THE BOTTOM OF THE HILL (1/4 mi). (ABOUT 12 MILES FROM HWY 86.)

FROM COLORADO SPRINGS:

EAST ON HWY 24 TO CALHAN. NORTH ON CALHAN HIGHWAY WHICH IS ONE OF THE LAST STREETS IN TOWN. (THERE IS A SIGN THAT POINTS TO THE AIRPORT, THIS IS THE ROAD!) DRIVE 7 1/2 MILES, YOU'LL COME OFF PAVEMENT AND YOUR NEXT LEFT WILL BE ROAD 78. TURN LEFT AND DRIVE 3/4 MILE TO THE ENTRANCE.
