All tests are open to all AKC registrable Pointing Breeds 6 months of age or over. Bitches in season may be run at the last brace of the day only.

Entries will be limited to the number of dogs that can be run during daylight hours. Entries will close when the limit is reached if this occurs prior to the specified closing time! **Enter early!**

Entry Fees include a \$3.00 Processing Fee. Entries may be cancelled or changed online prior to close of entry, with refunds (less a Processing Fee of \$3 per entry and \$1 per camping item) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and camping items may be cancelled online after close of entry, but no refunds will be given. Once an entrant is drawn and braced, it may run as entered, move up to the next test level, or scratch without refund. Refunds (less the \$3 Processing Fee) will be granted only for bitches in heat, injured, or sick dogs (may require vet Certification); or as deemed an emergency by the event committee. Entrants who complete a title during #2019149002 may request advancement to the next level for event #2019149003 to the event secretary within 30 minutes of the test start.

From Highway 36 and 71 (Last Chance, CO)  
Go East, 9.7 miles, toward Lindon, CO.  
Go right (South) on County Road S for 4 miles. (First right hand turn after getting into Lindon)  
Go right (West) on Road 8 for 1 mile.  
Go left (South) on Road R for 1 mile.  
Go right (West) on Road 7 for 1 mile.  
Go right (North) on Road Q for ½ mile.  
Road Q (is poorly marked and looks like a farm road), It is the entrance to the hunt test area (Ohr Ranch).  
There are many roads that you can take to the grounds, but for trailers, this is the recommended route.
